Release of Liability, Waiver of all Possible Claims and Assumption of Risk for Covid-19

Heritage Banquet Hall **requires** that all event organizers who rent our facilities **MUST** follow Provincial Health guidelines as per ORDER OF THE PROVINCIAL HEALTH OFFICER GATHERINGS AND EVENTS (Pursuant to Sections 30, 31, 32 and 39 (3) Public Health Act, S.B.C. 2008 – Excerpt quoted below) The event organizer **MUST** ensure the following conditions are met:

- **provide the owner/operator of Heritage Banquet Hall with a copy of the first and last names and telephone number, or email address, of all the patrons who attend your event.** The contact information will be retained for thirty days and forwarded to the Medical Health Officer in case there is a need for contact tracing; otherwise the information will be destroyed after 30 days;
- access to the event is controlled and strictly monitored;
- Maximum of fifty (**50**) patrons per venue is allowed;
- patrons to maintain a distance of two metres from one another when standing or sitting, unless they belong to the same party;
- no more than six patrons sit at a table, even if they belong to the same party, and there are at least two metres between the backs of the chairs at one table and the backs of the chairs at another table, unless the chairs are separated by a physical barrier;
- a three-metre separation or a physical barrier must be installed between a performer, presenter or presider and the patrons to blocks the transmission of droplets
- hand sanitation supplies are readily available to patrons;
- washroom facilities are accessible for hand washing purposes

I further acknowledge that the Releasees can rely on this Release of Liability, Waiver of all Possible Claims and Assumption of Risk as a complete defence to any and all claims, damages, causes of action, or recourse or liability that may arise at any time.
